Highway Location: Town of Wilmington
Authority in Control: Town of Wilmington
Name of Highway (s): Church Street, Middlesex Avenue
and Salem Street (Route 62)
Shawsheen Avenue (Route 129)

In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter.Ed.) as amended, the following Special Speed Regulation is Hereby adopted by the Board of Selectmen of the Town of Wilmington

That the following speed limits are established at which motor vehicles may be operated in the areas described:

Church Street, Middlesex Avenue, Salem Street (Route 62) Eastbound

Beginning at a point 265 feet east of Main Street, (Route 38) thence easterly
